**ORAMMA is a 2 year project, funded through the [European Union's Health Programme](#), to develop an approach to maternal healthcare for migrant and refugee women.**

**ORAMMA is now into its second year, and the partners have been working to implement the ORAMMA approach. The first part of the project - exploring the current situation for pregnant migrant women and creating recommendations for improvements based on the evidence - is now completed.**

**The teams in Greece, the Netherlands and the UK have recruited pregnant migrant women, healthcare professionals, and Maternity Peer Supporters to the pilot. Now, recently arrived pregnant migrant women are being supported through their pregnancy by professionals trained in the ORAMMA approach and by a maternity peer supporter who speaks her language and can help her navigate the health and social care system in her host country.**

## **Migrant Mothers Matter Too: Working Together for a Better Community**

**ORAMMA has been working to train health professionals across relevant disciplines in Greece, the Netherlands, and the UK in the ORAMMA approach to ensure they are able to support migrant mothers. The systematic review undertaken during the project produced the following ORAMMA recommendation:**

**Healthcare professionals should be supported to develop cultural competence to enhance their interactions with migrant women and other vulnerable clients.**

**The project team in the Netherlands, RadboudUMC, hosted a booster training for their project midwives to ensure that the**

**cultural competence training initially delivered in January was being retained and implemented.**



### **Disseminating project findings**

**On the 18th May, ORAMMA partners from Sheffield Hallam University and Radboud University presented some of ORAMMA's work at the World Congress on Migration, Ethnicity, Race and Health in Edinburgh.**

**The title of the talk was 'Migrant women's experiences of perinatal care in European Countries: a systematic review'. Dr Soltani and Dr van den Muijsenbergh discussed the process of undertaking the systematic review as a part of the**

ORAMMA project and presented the following messages which emerged during the review:

"Migrant women need 'trauma aware care' and culturally competent, compassionate health professionals who listen to them and provide respectful, dignified, and equitable perinatal care, supported by multi-disciplinary team-working and continuity of care. They need models of perinatal care which go beyond clinical care and address their social and economic challenges."

As you know, with the introduction of GDPR regulations, we need to update you on our privacy policy.

A new European legislation, entitled, "**General Data Protection Regulation (GDPR)**" came into effect on **25 May 2018**. The new law provides rights to individuals about how the ORAMMA project handles their personal data.

In particular:

- You have the right to access to any personal data, about yourself, that you have provided to the ORAMMA project.
- You may request that ORAMMA amend the data, without delay, if the data that we have is incorrect or incomplete.

- You have the right for your data to be permanently erased – you may request ORAMMA to erase your personal data without undue delay.
- You can object to having your personal data captured, stored and used and request that your data be deleted if you believe that the processing is unfair and unlawful.

At ORAMMA we are in possession of your contact details, including name, email address, organisation affiliation. We use these contact details to provide you with the ORAMMA e-newsletter and any relevant information/updates in regard to the ORAMMA project.

According to the GDPR, you may ask us to delete your contact information. If you would like us to delete your information, then please let us know what information you would like us to delete, by replying to this email.
